#### APPEAL DECISION

Appeal Ref: APP/W0340/W/19/3232761 The development proposed is the construction of a one and a half storey dwelling with a detached garage at land to the rear of Burford Cottage.

THE APPEAL IS DISMISSED

#### **NEW APPLICATIONS**

1) 19/02977/FUL Bradstone House, Southend Road, Bradfield Southend. New workshop/office/shop building to provide accommodation for Bradfield garden machinery.

Extension to existing commercial garage, to provide vehicle storage.

Demolition of existing car port.

Existing shop to be converted to residential use as part of Bradstone House.

#### 'NO OBJECTION'

2) 19/03055/PACOU Elmwood Building, Southend Road, Bradfield Southend. Application to determine if prior approval is required, for change of use of offices to 5X apartments.

Concern that parking on site is not sufficient for this local location, or on multi junction for street parking.

3) 19/03063/LBC2 Bradfield College, Bradfield Re-roofing all pitched roofs, including replacement of existing tiles, timber battens and felt and associated timber repairs to roof structure, replacement of dormer cheeks to dormer windows and replacement of two dormers and associated window frames. Replacement of roof lights, rainwater goods, access ladder, mansafe handrail and snowguards. Removal of ventilation pipes. Timber repairs to ground floor northern elevation. Like for like repairs to hanging tiles, brickwork, stonework, pointing and window frames and panes. Repairs to flat roofs. Internal works including replacement of sanitaryware and installation of wet heating and ventilation system and new light fixtures in ground floor WC's and IT suite; replacement of ceiling in IT corridor; replacement of WC doors, installation of secondary glazing in roadside windows, removal of stud partition wall between RPE Office and BD7 classroom and installation of replacement glazed partition and associated rerouting of services; replacement of stud partition wall between English Office and corridor and replacement with glazed partition, installation of built-in cupboards in English and RPE Offices, replacement of built-in cupboard in BD7 classroom, reconfiguration of doors in RPE Office. Installation of electric radiator in RPE Office. Associated internal repairs to match existing.

'NO OBJECTION' Concern over scaffolding ingress (likely) on to highway.

4) 19/03107/HOUSE Oak House, Bishops Road, Tutts Clump. Proposed garage and garage loft conversion. Rear orangery extension, and detached double garage.
